HEALTH & SAFETY DIRECTOR'S REPORT

There were a few minor incidents, one being a cut finger, where a member of public touched what they shouldn't. Members are reminded to keep all sharp objects stowed away safe unless they are being used. If anything is out for display, blades should be blunted, or signs displayed 'Do not Touch' and a careful watch kept.

There was one major incident, a broken femur. While negotiating a low rope barrier, a member landed heavily and snapped their femur. After consideration of the circumstances of the accident, no specific alterations to our policies and practices suggested themselves. This was simply a freak accident for which no one is to blame. Members are nevertheless encouraged to take extra care when negotiating rope fences to further minimise the already small chance of a recurrence.

Members had an opportunity to practise this due care and attention at Whitby, where we had to negotiate a barrier put in place between our camps and the toilet facilities. Thanks to those that brought this the H&S director's attention; the person running the railway was persuaded to remove some rails to clear the way on the first evening it appeared. At later points, our members negotiated round or over this obstacle without further incident.

Thanks to those who reported incidents. A good Health and Safety culture features reporting of large numbers of minor incidents and near-misses, in the hope that major incidents are avoided by proper attention to H&S issues. A form for medical incidents is now in place. We will generate a form for reporting of other H&S issues and near-misses for use in the coming season.

This season, there was one near miss, regarding the collaboration with members of another society, who were unfamiliar with our safety distance rules. Since those people are not signed-off on our FSPC system, it is hereby made clear that there can be no repeat of this situation. Unless everyone signs a guest form and is tutored by the senior NCOs on the key safety distance points, they cannot participate in any ACWS arena scenario, whether that be at a regimental or full-society event.

In the background, the committee have been updating all the Rules and Regs documents to be found at https://acws.co.uk/rules-index updates shall appear in the close season.

Company commanders are thanked for their co-operation in administering the FSPC (Firearms Safe Practise Certificate) system. Any new recruits or people returning after being away last season must get FSPC forms filled in with their unit leader, with copies to H&S Director (electronic or hard copies are acceptable) at the earliest opportunity, which will be Whittington, April 1st 2023.

Finally, a reminder: licence renewals are taking long periods at present with many forces, so members are encouraged to get renewal requests in early (2-3 months in advance) if licences are due for renewal in the coming months/year.

This report is commended to the AGM as an accurate summary of H&S business in 2022.
